DEAN'S WELCOME MESSAGE

The International Conference 2024: Expanding Potential and Caring for All will take place on 8, 9, and 11 November with Mr. Chris Sun, JP, Secretary for Labour and Welfare, as our officiating guest. We have selected three important themes for this year's international conference. Two of these themes focus on informal caregiving: "Caregiving policy and practice in Hong Kong: International perspectives and local initiatives" and "Voice from the informal caregivers: A global dialogue on navigating challenges and cultivating support" The third theme is "Applying data science to social sciences". The significance of these themes is self-evident, and we have invited renowned researchers to present at the three-day conference. We hope to attract participants from academia, practitioners, and service users alike.

Hong Kong Shue Yan University (HKSYU) is our esteemed partner in theme related to caregiving policy and practice and plays an important role in this conference as a co-organiser. The sessions on November 11 will be held at the HKSYU campus.

We extend our heartfelt gratitude to the Research Grants Council (RGC) for funding our research projects on caregiving and data science, which include organising international conferences. We are also thankful to our seven supporting academic institutions and NGOs, whose senior staff members are instrumental in organising this conference. This event also marks the 20th anniversary of our Felizberta Lo Padilla Tong School of Social Sciences.

This year we also celebrate the recognition of acquiring the university title: Saint Francis University (聖方濟各大學). Both milestones are the culmination of years of dedication from our devoted teachers, academic and religious leaders, colleagues, alumni, students, and various stakeholders. This conference is also the second international conference celebrating our anniversaries, the first being in 2019 during our 15th anniversary celebration. Over the past five years, we have achieved self-accreditation status for our social work programs (PAA status) in 2021. Additionally, our student population has grown from 1,100 in 2019 to 1,300 in 2024. Currently, we have over 3,500 graduates from all our programmes, with an additional 480 graduates this year alone, most of whom are from our social work programmes.

In addition to our teaching programmes, we have made significant strides in our research endeavours. Currently, we are engaged in 20 research projects in collaboration with NGOs, government bodies, and various disciplines within higher education institutions. Our research efforts are gradually clustering into several major areas:

- policies for an ageing society,
- care supports and policies,
- children, youth and families,
- mental health and addictions,
- poverty and sub-standard housing, as well as
- the application of data science in social policies and social services.

Our research funding is sourced from the RGC, the Chief Executive's Policy Unit, other Bureaux and Departments of the HKSAR Government, the Macao SAR Government, charitable foundations, NGOs, and internal research grants.

As a new university, we aspire to integrate knowledge creation, teaching, practice, and services seamlessly. Our goal is to create a platform for collaboration and knowledge advancement that expands the potential of everyone involved and fosters a caring society that prioritises the well-being of all its members.

Keynote speech 1 Policy development of caregivers support in the global aging society

Prof Iris CHI

Professor Emeritus of Social Work University of Southern California

Abstract

As the global population ages, the increasing demand for caregivers presents significant challenges. Caregivers' well-being is crucial for both the quality of care and the sustainability of healthcare systems. Some regions with ageing populations have implemented support policies, including income security, health and social support, and access to information and education. Given the complexity of policy development, this presentation aims at reviewing the key international studies on caregiving policies and their social impact on caregivers, guided by the priorities outlined in the Global State of Caring report from the International Alliance of Carer Organizations. In summary, no comprehensive global policy exists, regional policies vary by culture and healthcare systems, and knowledge of best practices remains limited. Although existing initiatives may assist caregivers to some extent, they predominantly focus on facilitating care provision rather than promoting caregivers' well-being and flourishing.

Keynote speech 2
Policy and practice in supporting informal caregivers of people with intellectual disabilities in Canada

Prof Tim STAINTON

Emeritus Professor, School of Social Work Co-Director, Canadian Institute for Inclusion and Citizenship University of British Columbia

Abstract

This presentation will provide an overview of Canadian policies and practices related to informal caregivers of persons with intellectual and other disabilities. In Canada, social services are a provincial responsibility and as such policies with vary across all 13 Canadian Jurisdictions. We will briefly review the limited federal benefits available which are exclusively financial. We will then consider provincial benefits with a primary focus on British Columbia with some reference to other Provinces with unique policies. Unlike federal supports, the main caregiver supports provincially focus on respite rather than financial supports. We will consider both child and adult benefits. Lastly, we will consider non-governmental supports which play a significant role in supporting caregivers in Canada.

Keynote speech 3 Caregiving policy and practice in Singapore

Dr Carol Hok Ka MA

Associate Professor Head, Gerontology Programmes Senior Fellow (Experiential Learning) Singapore University of Social Sciences

Abstract

By 2026, Singapore is projected to become a super-aged society, with 21% of its population aged 65 and older. The rapid ageing of the population has elevated caregiving support to a critical policy priority. In response, the Singapore government has introduced a range of initiatives aimed at promoting healthy ageing, including the Successful Ageing Plan on Ageing, Healthier SG, Age Well SG, and Forward Singapore. Additionally, a comprehensive suite of caregiving policies has been developed, addressing key areas such as workplace support, care navigation, financial assistance, respite services, and the empowerment and training of caregivers.

To foster evidence-based solutions, the government actively promotes collaboration between academia and industry to generate innovative research and develop an integrated caregiving ecosystem. This paper also explores community-driven initiatives and the pivotal role caregivers play in enhancing caregiving practices. Further discussions on caregiving policies and practices will be conducted during the presentation.

Keynote speech 4
Caregiving policy & practice in Hong Kong

Prof Alice Ming Lin CHONG

Abstract

This presentation will provide an overview of policies and practices related to support to informal caregivers of frail older people and persons with disabilities in Hong Kong. We will highlight the recommendations of the Consultancy Study on Caregiver Support and review the degree of adoption of the recommendations by the government. We will also examine the responses and initiatives undertaken by the welfare sector and the charity foundations towards caregiver support. Lastly, we will identify service gaps and propose some directions for future development of caregiver support.

THEME 2-

Applying data science to social sciences

Social science has always made good use of data to explain interesting social phenomena and make the case for social policy recommendations. As we move into the digitalised age, all kinds of data and computer algorithms have become more and more available and applied in all kinds of scenarios, in particular, various business operations. How has this wave of new-born data science benefited social policies and services? How has data science evolved, both methodologically and culturally? What are the new problems and areas in social science worth applying data science to? These are some of the questions we will explore with our invited speakers and panellists in this session.

Keynote speech 5
Societal computing – Computing of and for society

Prof Ingmar WEBERAlexander von Humboldt Professor in Al
Saarland University

Abstract

Over the past 15 years, the number of academic papers discussing "Computational Social Science" (CSS) has steadily increased from 34 papers using this term in their title in 2009-2010, to 80 in 2019-2020, to 103 in 2022-2023, based on Google Scholar. Over the same time, many courses and even complete study programs have sprung up at top-tier universities. Despite this, CSS has not yet lived up to its potential as it still remains largely purely academic. Put differently, great efforts have been made on the computing of society, i.e. using non-traditional data sources, such as social media, to study societal phenomena. However, what is largely absent are honest efforts to go beyond this towards computing for society, i.e. working with partners to put insights into action and to support social development. I refer to this evolution of CSS, i.e. the combination of computing of and for society, as Societal Computing. In this talk, I'll give an overview of some of our past Societal Computing work where we had a real-world impact, in particular in humanitarian contexts. I'll close by zooming out and reflecting on various structural challenges that come with working in this interdisciplinary domain.

Improving engagement experiences with youth at risk: A text-based emotional support system

Prof Paul YIP

Abstract

Openup is a 24-hour text-based emotional support system, and it aims to provide an online and offline support system to youth at risk. In this talk, we shall highlight how to make use of big data analytics in the engagement experiences with the youth at risk, including risk classification, good practice modelling and service efficiency.

ICT and data science for social good

Prof Reynold CHENG

Head and Professor Department of Computer Science The University of Hong Kong

Abstract

In this talk, I will discuss how we employ Information and Communication Technologies (ICTs) and data science to enhance service quality of family care centres in the Hong Kong Jockey Club SMART Family-Link Project. First, I will present i-Connect, a large-scale, cloud-based, and secure software platform that streamlines administrative work of social workers in all NGO-based family care centres. The i-Connect system offers a user-friendly interface, as well as complex workflow and service boundary functions for family care centre supervisors and frontline social workers. I will further discuss the Data Analysis System (DAS), which provides software tools tailor-made for professional family care users to analyse data collected from i-Connect and other open data sources. By integrating these various data sources systematically, users can extract important insights about family care problems interesting to their centres and Hong Kong SAR. DAS also features a state-of-the-art AI-based system that allows users to formulate family-care-related questions conveniently in natural languages. Finally, I will briefly share how my HKU STAR (Social Technology and Research) Lab engages in "data science for social goods", using data science technologies to support volunteering and elderly services.

Out of the (tool)box: Large language models as research tools and subjects

Abstract

The advent of large language models has prompted scholars to rethink our approaches to data labelling. Moreover, some researchers are exploring ways to leverage these models, suggesting that role-playing language agents could effectively simulate human actors in diverse scenarios. In this talk, I will present specific studies that highlight how we can utilise large language models not only as powerful research tools but also as significant subjects of study themselves. This talk will uncover the transformative potential of these models as well as related challenges in enhancing our understanding about the "society".

Panel discussion Experiences of inter-disciplinary research in computational social science

Keynote speech 6

The global phenomenon and power of informal caregiving: Implications for social work

Prof Patrick O'LEARY

Professor School of Health Sciences and Social Work - Human Services and Social Work Griffith University, Australia

Abstract

Every human society has informal caregiving it is the bedrock of family and community functioning. It is always occurring whether the time is peace and harmony, as well as in times of public crises, disasters, war, and oppression. The resilience of informal caring is that it outlasts governments and transcends generations. Informal carers are by their very nature often invisible and tireless, they may even go about their care not fully realising the significance and essential nature of their work. Yet increasingly in times of changing demographics, economic pressures and social dislocation, this system is stressed and vulnerable. At the same time, the demand for unpaid support is increasing as many states have diminished funding for social support services. Often the caregiver demands fall unequally on women, families, and communities who have multiple and often compounding issues of disadvantage, trauma, and discrimination.

Social work stands in an important yet complex position to be activists lobbying for better state resourcing of social support services while also providing fundamental advocacy and support to caregivers. Facing this situation, there is a need for a paradigm shift, to better understand the value of the diverse range of informal caregiving but also how it can be better part of formal care and social support services and structures. To fully understand this the lived experience of caregivers and their recipients needs to be heard and responded to. In this presentation some concepts for supporting this paradigm shift will be explored. This requires and understanding of the dynamic complex intersectional considerations that involve informal caregiving. The presentation concludes by examining the unique position of social workers to strengthen the status and support of caregivers while preserving their intangible value to improving the lives of their loved ones. At the same time, social work must work with formal systems of support to be resourced appropriately to fulfil its duty to care recipients, caregivers, their families and communities.

Roundtable Discussion

Building on the insights from the keynote speech, the roundtable discussion will go further into the common needs and help-seeking patterns of informal carers across different regions, with a focus on the Chinese people in Vancouver, Brisbane, and Hong Kong. The panelists conducting a cross-regional study on informal caregiving will share their findings and perspectives on the key challenges informal carers face and how they navigate and utilise community services and support systems.

The discussion will explore the similarities and differences in the experiences of informal carers in diverse cultural and socioeconomic contexts through an interactive dialogue. The panelists will also examine the implications of their research for developing more comprehensive and accessible support frameworks to empower informal carers in their care planning. Participants will have the opportunity to engage directly with the panelists, asking questions and sharing their insights on the complex realities of informal caregiving. This roundtable session is designed to provide a platform for meaningful exchange, fostering an understanding of the global nature of this critical social issue.

The design and use of mobile applications in caregiving support

Prof Iris CHI

Professor Emeritus of Social Work University of Southern California

Abstract

The well-being of caregivers is critical to sustaining an economically viable healthcare system for our aging society. Technology has emerged as one of the key solutions, helping caregivers manage both their loved ones' needs and their own well-being. According to several studies, caregivers show a moderate to high level of receptiveness to using mobile health (mHealth) applications (apps) for caregiving support. Consequently, the development of mHealth apps has grown, offering various resources for caregivers. However, most mHealth apps primarily focus on providing easier access to caregiving resources, with only a few incorporating self-care functions such as app-based support groups, stress trackers, and health maintenance advice. Additionally, many apps lack a theoretical framework to guide their development, and there is still limited evidence regarding their effectiveness in improving caregivers' health outcomes. This presentation will introduce an integrative body-mind-spirit health model designed specifically for the East Asian caregivers, alongside a user-centered mHealth app design process.

Age+ Living Lab: Joint initiatives with caregivers to promote ageing in place in Singapore

Dr Carol Hok Ka MA

Associate Professor Head, Gerontology Programmes Senior Fellow (Experiential Learning) Singapore University of Social Sciences

Abstract

The Age+ Living Lab is Singapore's first community-based living lab dedicated to promoting aging-in-place through the integration of gerontology and assistive technology. It serves as a collaborative space where seniors, caregivers, community partners, and solution providers can exchange knowledge and co-create innovative solutions to address the evolving needs of Singapore's aging population. The Living Lab is led by the Gerontology Programme at the Singapore University of Social Sciences (SUSS), in partnership with a

caregiver resource center operated by SG Assist. This initiative aligns with national efforts such as Age Well SG and Healthier SG, as well as the World Health Organization's Healthy Ageing initiative, which aims to promote environments that enhance intrinsic capacity and functional ability in older adults.

The Age+ Living Lab also functions as a platform for experiential learning, offering tours and activities that allow seniors, caregivers, and the public to explore the role of assisted living technologies in supporting caregiving. Through joint efforts, the research team has identified key strategies to support caregivers and older adults throughout the caregiving journey, culminating in the development of the "6 As Framework" to guide the selection of appropriate products for aging-in-place.

Families as employers using individualized funding

Prof Tim STAINTON

Abstract

Individualised funding, or more broadly, self-directed supports, are increasingly the preferred means of supporting individuals with disabilities. For people with intellectual disabilities, this commonly means the families directly employ or control the support workers engaged to support their child with a disability. Drawing on a number of recent studies undertaken by the Canadian Institute for Inclusion and Citizenship and the presenter, this talk will explore what individualised funding is, how it is being used in various jurisdictions and, how this is impacting family caregivers. Finally, we will briefly consider the pros and cons of individualised funding for future policy and practice.

Elevate caregiving: Harnessing I&T to empower

Dr Donna BROWN

Associate Director, Engagement Hong Kong Science and Technology Parks Corporation

Abstract

Dr. Brown, representing the Hong Kong Science and Technology Parks Corporation (HKSTP), will explore the pivotal role of innovation and technology in enhancing caregiving. With the United Nations predicting that by 2050 Hong Kong will have the world's oldest population, the focus will be on addressing the challenges posed by an ageing demographic. These challenges include staffing shortages in the elderly care sector, chronic diseases, swallowing difficulties, safety, cognitive problems and loneliness in elderly living, all of which can be mitigated through technological solutions.

With over 2,000 tech companies under HKSTP, including more than 70 specialising in Gerontech, HKSTP has formed a dedicated team to support the development of technology for elderly and rehabilitation care. Dr.

Brown will share various use cases and testimonials demonstrating successful technology adoption in care services, such as fall risk management tools, cognitive support, and soft meals implemented by NGOs and caregivers. This highlights the effectiveness of innovative solutions in transforming elderly and rehabilitation care.

Emphasizing cross-sector collaboration, Dr. Brown will share HKSTP's initiatives designed to support the development and adoption of innovation and technology in the caregiving. These include the establishment of a dedicated Gerontech hub, testbeds, consultancy services, industry engagement and service talents training programs. Such efforts aim to foster technology adoption in elderly care and social welfare, ensuring that caregiving is well-supported to meet the evolving needs of Hong Kong's aging population.

Caregiver Support Model 2.0 - Train-the-trainer model

Abstract

BACKGROUND: The Caregiver Support Model (CSM), incorporating the Caregiver Needs Assessment (CNA), is a validated case management model. To enhance its impact, a train-the-trainer model was used to equip social workers in Hong Kong to implement the CSM protocol. The training package includes 15 hours of basic training, a 3-month practicum with monthly supervision, and bi-monthly practice-circle sessions.

METHOD: Forty-five social workers from nine NGOs participated, completing an online assessment regarding their perceptions, confidence, and willingness to recommend CSM before and after the basic training.

FINDINGS & DISCUSSION: The results indicated significant improvements in various areas: perceived attractiveness (d=1.14), perceived limitations (d=0.58), willingness to implement (d=0.46), implementation confidence (d=0.51), and willingness to recommend CSM to others (d=0.43). These findings suggest the training was successful. Further data at the end of the project will determine if social workers are willing and able to further disseminate CSM.

Equipping caregivers of the next generation: Impactful research and teaching curriculum

Current trends and challenges in caregiving research

Prof Iris CHI

Professor Emeritus of Social Work University of Southern California

Abstract

Several medium- to long-term socio-demographic trends are expected to increase the demand for informal caregiving while simultaneously reducing the availability of informal caregivers. These trends present both challenges and opportunities for the field of caregiving research. The existing literature highlights a wide range of research gaps that must be addressed to develop a 21st-century system capable of supporting caregivers. These gaps span various stages of the caregiver policy and program development process, including needs assessment, policy formation, stakeholder engagement, legislative and regulatory review, policy adoption and implementation planning, as well as monitoring and evaluation. Additionally, there are significant gaps in study topics and methodologies, such as policy analysis, cost-benefit and economic evaluations, policy advocacy for diverse caregiving populations, and impact studies. This presentation will explore the implications of these trends and the challenges they pose to conducting caregiving research.

The impact of the Namaste Care™ programme in spiritual end-of-life care service for families and staff in Hong Kong: A pilot study

Abstract

The Vera Ruttonjee Desai Spiritual End of Life Care Centre (VRDSEOLCC) in Hong Kong aims to enhance the quality of life for caregivers and Chinese older adults facing terminal illness. This study explores the experiences of families of older adults with advanced cancer and staff at VRDSEOLCC within Hong Kong's cultural context.

Using semi-structured interviews with 20 staff and family caregivers, the research examines their involvement in Namaste Care™ programs. Thematic analysis of the qualitative data revealed seven positive themes: honoring inner spirit, inducing hope, fulfilling wishes, engaging in meaningful activities, compassionate care during the dying process, and embracing gratitude. The spiritual care team plays a vital role in delivering a structured Namaste Care™ program that aligns with the holistic needs, culture, and values of older adults. Participants benefit from daily one-on-one or group sessions, fostering close communication with family members.

The study indicates promising outcomes for family caregivers and spiritual care workers in supporting older adults with advanced cancer. It underscores the effectiveness of integrating the Namaste Care $^{\text{m}}$ approach into holistic aged care services. Further rigorous studies are needed to deepen the understanding of VRDSEOLCC's impact and the Namaste Care $^{\text{m}}$ program in Hong Kong.

Using Generative-AI to support carer telephone support services: Preliminary findings

Abstract

This experimental study explores the utilisation of Generative-AI, specifically Large Language Models (LLMs), to support Carer Telephone Support Services in Hong Kong. The demand for these services, which operate 24/7, requires substantial manpower for tasks such as answering calls, making outbound calls, and preparing call summaries. This study, conducted in collaboration with the Hong Kong Federation of Women's Center Carer Support Services Hotline, involved recording 71 calls with the consent of caregivers. These recordings were transcribed verbatim and analysed by both an LLM known as Copilot and an experienced social worker. The findings reveal that Copilot can effectively identify challenges faced by caregivers. However, it struggles to contextualise information within the dialog content, often overgeneralizing, over-simplifying, or creating new content, likely influenced by the design of the prompts used. These initial results highlight the potential of LLMs in reducing the manpower demands of such services, though they also underscore the need for future research focused on enhancing the comprehension abilities of LLMs and improving prompt design to ensure more accurate and contextually appropriate responses.

Digital competence, caregiving self-efficacy, and social connectedness among informal carers of hospitalised patients

Abstract

The study explores the mechanisms in the association between self-efficacy in caregiving (SEC), digital competence (DC), and loneliness among 200 informal carers for hospitalized patients. Conditional process analysis reveals a moderated mediation effect of DC on social network, and SEC, increasing carers' health-related quality of life and reducing loneliness. Our model also found that a larger social network significantly reduced caregiving hours and the burden of care, correspondingly reducing loneliness. Results suggested that better digital competence can increase carers' self-efficacy in caregiving, resulting in positive caregiving outcomes. Therefore, health and social care practitioners should effectively use technology-based interventions to enhance carers' competence in caregiving. Strategies to strengthen carers' social connectedness are also essential to combat the negative outcomes of caregiving

Building a carer and dementia friendly community: The impact of the "Dementia Hand in Hand" project

Abstract

The "Dementia Hand in Hand" project aims to cultivate a carer and dementia-friendly community. Coinitiated and co-funded by the Ho Cheung Shuk Yuen Charitable Foundation, Chow Tai Fook Charity Foundation, and Shih Wing Ching Foundation, the project has invited the Sau Po Centre on Ageing at The University of Hong Kong as a knowledge partner. Baptist Oi Kwan Social Service launched this three-year project from October 2021 to September 2024, serving the carers of dementia and frail elders in two public housing estates (Cho Yiu Chuen and Lai Yiu Estate) with locational service needs.

The project emphasises that every carer should be respected, valued, and supported. It advocates for a "Carer Rest Day" and provides comprehensive services to elders and carers. The core services include early identification, carer self-planning, carer advance directives, respite services, and peer support training programs.

The presentation will share a community-based intervention protocol and the experience of providing Carer Rest Day services, highlighting their effectiveness in alleviating carer burden and depressive symptoms. Practical Approaches to Education on Informal Caregiving -Incorporating Informal Caregiving in Curriculum of Health Care Professionals

Abstract

This presentation focuses on the incorporation of informal caregiving into the curriculum for health care professionals, specifically from a physiotherapy perspective. Informal caregivers, often family members or friends, play a vital role in the rehabilitation process, yet their contributions are frequently overlooked in

clinical practice. We will discuss the importance of recognizing the needs and challenges faced by informal caregivers and how their involvement can significantly impact patient outcomes.

The presentation will outline curriculum strategies that enhance physiotherapy education, including the integration of case studies, role-playing scenarios, and workshops designed to foster collaboration between physiotherapists and informal caregivers. By equipping future physiotherapists with the skills to engage effectively with caregivers, we aim to promote a holistic approach to patient care.

When children with intellectual disabilities grow up, parents' expectations and worries

Abstract

In Hong Kong, individuals with intellectual disabilities are required to graduate from special schools and transition to adult employment services or public employment once they turn 16. From 2023 to 2024, a study was conducted to understand the needs of individuals with mild to moderate intellectual disabilities during the transition stage, as well as the expectations and concerns of their caregivers. The study employed a mixed research method. Qualitative study involved 40 participants, including special school staff, parents, adult social service social workers, and students with intellectual disabilities. The quantitative research collected a total of 383 questionnaires. The research findings revealed that parents are worried about their children's ability to handle work-related difficulties, the availability of suitable employment opportunities, and the possibility of workplace discrimination. Parents expressed a strong desire for their children to participate in vocational experience classes at vocational training centres, engage in job trials and internships at adult employment service agencies, and take part in skill development courses such as pastry making and hotel cleaning work. Additionally, parents expect special schools to design courses focused on vocational training, assist students in applying for the central referral system for rehabilitation services, and refer students to regional support centres.

Unveiling stress coping in the resilience journey of caregivers of children with special educational needs through Photovoice in Hong Kong

Abstract

The presentation will introduce a novel to investigate parental stress levels and coping strategies among caregivers of children with SEN in Hong Kong. Using a participatory action research approach and

Photovoice design, the study will explore stress sources, quality of life perceptions, and the efficacy of Photovoice as an intervention. By integrating the Coping Circumplex Model and the Common Factor Model, the research seeks to provide insights for educators and clinicians, potentially preventing family tragedies and enhancing caregiver well-being. With 30 participants across different child developmental stages, the study will yield practical outcomes, including a Photovoice Work Manual and a website for dissemination. This proposal promises to benefit caregivers, practitioners, and the wider community, contributing to a more supportive environment for children with SEN.

2024年,香港進入超高齡化社會,在未來 10年,香港 85 歲或以上的人口增長速度特別快。雖然人口高齡化與體弱沒有必然的聯繫,但是在老化過程中由於身體衰弱/心理困擾/或者認知缺損的情況會更常見。換句話說,越來越多的家庭成員會不可避免的進入照顧者的角色。文獻顯示照顧者由於長時間投入照顧工作,更容易出現身體疲勞,精神緊張,甚至抑鬱。但是過去的研究大多運用單維度測量(例如照顧者負荷),或者精神健康的指標(例如焦慮/抑鬱),或者二個方面的綜合(例如情緒自評量表)來評估。雖然這些評估工具能夠找到精神健康受到困擾的照顧者,但是沒有能具體標定照顧者相關的需要。在香港賽馬會慈善信託基金的支持下,由香港大學秀圃老年研究中心團隊協同六家非政府機構(包括香港明愛,基督教香港信義會社會服務部,香港婦女中心,香港聖公會麥理浩夫人中心,香港基督教女青年會,東華三院),結果文獻回顧,專家共識,初步項目形成,問卷調查研究等等科學步驟,發展了 11 個項目的具有滿意信度和效度的照顧者為本的需求評估工具,面前在 9 家照顧者中心試用,協助工作團隊評估照顧者需要,並根據需要提供適切的服務。

Abstract

Johnson & Johnson and Singapore University of Social Sciences established the Ageing Business Roundtable for an Asia-centric discussion on ageing in the business realm. It involves business stakeholders in sharing best practices for active ageing. The roundtable offers insights on demographic shifts, caregiving for employees, challenges, and opportunities from community-corporate partnerships. Over 120 participants from various sectors, including Diversity, Equity, and Inclusion (DEI) initiatives, engaged in discussions on sustainable ageing solutions and innovative approaches in Asia. Recognised by the Ministry of Health, the initiative has led to the development of an age-friendly HR framework to serve as a guideline for organizations aiming to foster an age-inclusive society.
